558	Registered parties filter formatting	The formatting of the filter fields available in the Registered parties screen under the Participants and Observers tabs is updated for consistency with the filter fields in other eFiling screens.
563	Direction details user interface display	Misalignment and inconsistent spacing issues in the Direction details screen is fixed.
568	Recent Notifications missing links and tool tips	Proceeding number links and tool tips are restored in the two Recent notifications tabs on the eFiling home screen. The date created column is adjusted to no longer cut-off information.
585	Application(s) screen display issue	The spacing for the Applicant reference column in the Application(s) screen is adjusted and no longer cuts off text.
590	Set default description checkbox bug	In multi-application proceedings, in the uploader screen, when a user selects to default the filename as the document description the system no longer selects that the documents apply to all of the applications.
592	Revision uploader screen display	Spacing between field names and populated information is now aligned in the revision uploader screen.
595	Filings set to internal status message	Duplicate text is removed from the warning message prompting the user to confirm that their filing will be registered as internal only and will not be available to external users (example, transcripts).
598	Observers tab user interface issue	The filter symbol displayed in error in the document actions column of the Registered Parties screen, Observers tab, is removed.
601	Edit filing screen text alignment issue	Edit filing information window now aligns fields and data entered by a user.
608	Disabling document actions for system generated pdfs	The issue where the Document Actions button was active for system-generated PDFs even when no document actions were available is resolved. The button is now disabled providing an immediate indication that the document contains no actions for the user to take.
610	Select a filing type window alignment	Inconsistent column sizing and misaligned column sizing in the Select a filing window is corrected.

615	Confirm reset password window	Inconsistent format of action button is addressed. The reload error when attempting to close the window with the X is fixed.
616	Schedule status filter options	In the Schedules screen, the Schedule status filter no longer contains an incorrect menu item: InProgressAndNotStarted.
617	Create filing window text change	For consistency with the action being taken in the Create filing window, the message is updated to read "Select create filing" .
618	Disable action button in Registered party details screen	In the Registered party details screen the action button to remove the representative is now disabled for unauthorized users.
623	Confidential lock icon displayed in error in Filings screen	In restricted and confidential proceedings, the lock symbol representing a confidential filing is removed for public filing types.
626	Alignment adjustment for directions column	The alignment of the directions listed in the Directions column of the Filings details screen is adjusted to ensure consistent formatting across the system.
628	Disassociating direction confirmation message issue	When disassociating multiple directions from a document in a draft proceeding, the user is no longer required to confirm each direction being disassociated. All directions are listed in one confirmation window.
632	Associating directions action button text change	When selecting and then unselecting a direction(s) to be associated to a document, the confirmation action button no longer switches from Select to OK.
637	Forgot your Login ID?	The arrival and login screen is updated with a new function to report a forgotten login ID. A system-issued email will be sent to the user listing all active login IDs associated with the email address provided.
639	Direction response association performance issue	Associating multiple directions to a document now completes successfully without timing out. When disassociating multiple directions from a document, a single confirmation message is now issued, replacing the individual messages previously sent for each disassociation.
641	Contact table sort order	Various screens and windows containing a name column now sort in one click versus two clicks.
656	Password checkbox	For consistency across the system, the show password function now uses a checkbox in the login, register new single user, and password reset screens and windows.
657	Confidential permission message	The validation message displayed during the registration of a Motion for Confidentiality by a representative has been revised to inform representatives that they must obtain system permission from their clients to upload and access confidential motion documents.

661	Organization details mobile display	The scroll bar is restored when viewing Organization details succession history in a mobile device.
662	Go to capitalization issue	The system message displayed when selecting Proceeding, Application, or Disposition in the top navigation search bar without entering a number is updated to reflect the standard formatting applied across system messages.
663	Login screen capitalization convention	The labels for "Show password" and "Remember my login" are updated to follow proper capitalization conventions.
665	Incorrect empty grid message in screens	The empty grid message across several screens is updated to ensure consistency and clarity. This includes the Proceeding Home screen, Related proceedings window, Schedules, My Draft Filing, and Filings to Me.
676	Find filings screen, Filed by filter not responding	The search filter "Filed by" is now functioning and filtering for results.
685	Franchise agreement application validation error	The validation preventing a negative term from being used in a franchise agreement and franchise rate rider application is restored.
688	Logging in redirection page error	The incorrect redirection sequence upon logging out and logging back in is fixed. Users are no longer being redirected to the Search page instead of the Home page.
691	Validations for power plant application	Validations on the power plant application form are restored to prevent numbers less than or equal to 0 for various power plant data inputs.
692	Restricted proceeding upload flash	On a restricted proceeding, when uploading documents for a public filing, the screen no longer flashes the purple banner used to indicate a confidential document is being uploaded.
694	Observer proceeding notifications screen bug	The Notifications screen is updated to correctly show a party's subscription status when registering as an Observer.
696	Power plant interconnection application field alignment issue	The legal subdivision field label in the power plant interconnection application is expanded, no longer hiding label text.
700	Confidential uploader screen UI issue	Spacing misalignment for the action link to generate a summary page in the confidential uploader screen is adjusted.
701	Incorrect Exhibit numbering on proceeding registration	Upon registration of a proceeding, exhibit numbers are now being assigned in the order of the document upload.
706	Search results times out and throws error	The Search results screen no longer times out after being open with no activity for an extended period of time.
707	External users seeing internal notifications	Validations preventing external users from seeing notifications for internal only transcripts are restored.

711	External system resources window	The name of the action button to access the system user guide, quick tips and how to videos on the top navigation bar is restored to display the name How do I? Selecting the button now opens the eFiling how to window with all linked resources listed.
714	Released reports are not opening	Permissions for external users to open public reports available from the Reporting screen are restored.
720	Exhibit display in browser view	Exhibits opening in browser view now have PDF page number display and navigation. The [ctrl+F] shortcut key can be used for searching keywords in the document.
721	Proceeding description tool tip missing	The proceeding description tool tip is restored to proceeding numbers displayed in the following screens: eFiling home screen (Schedule summary, Task summary, Priority directions), and My tasks.
723	Confidential record in restricted proceeding	When a restricted proceeding contains a confidential record, the ability for a user to select to upload public or confidential files for their filing is restored.
726	Opening related proceedings	When selecting to open a related proceeding from a proceeding home screen, the related proceeding now opens in a new tab.
730	Search screen Property field	The Property drop-down menu in the Search screen is now listed in alphabetical order.
734	Search results sort default enhancement	The default sort setting for the results set in the Search results screen is updated to sort the results by the most recent upload date: Date(Newest).
738	Adding additional proceeding applicant behavior errors	Upon registering a new co-applicant to a registered proceeding, the system no longer re-generates the filing announcement in error. When the system-generated filing announcement or application form require re-flattening due to a primary or co- applicant update, the Documents screen is fixed to no longer re-sort exhibits listing the two documents at the top of the list in error.
739	Documents screen missing document download function	The download document function is restored in the document actions menu in the Documents screen.
740	Search results sorting menu	The drop-down sorting menu in the Search results screen is restored.
741	Find dispositions and directions missing default date type	The default criteria applied to the field: Date type used in the Find dispositions and Find directions screens now correctly displays the name of the date type being applied. Find dispositions defaults to Date type: Issuance and Find directions defaults to Date type: Due.
747	Notifications screen title correction	The title of the filter section in the Notifications screen is revised for consistency to read Notifications - filter criteria.

748	Notifications screen permission message	Only registered parties and those users whose organization is a registered party to a proceeding can view a proceeding's Notifications screen. The message for unauthorized users visiting this screen is updated for clarity.
751	Confidential access permissions	Validations are restored to prevent external users who do not have confidential access from editing a draft filing from a public to a confidential state.
754	Disposition issuance email notification to registered party contacts	The disposition issuance email was not being issued to registered parties who unsubscribed to receive notifications. This issue has been corrected. All registered parties will now receive an email when a disposition is issued, regardless of their subscription status.
756	Document actions view clean version opening in new tab	The document action 'View clean version' on a revised document is updated to open the clean version in a new browser tab.
762	Proceeding home schedule grid mobile display issues	When viewing schedules from a proceeding's home screen in various mobile devices, the "Final closing date" column is now fully displayed.
763	View application status mobile display	The application status column available from a proceeding's home screen, the Applications screen, and in the Select an application window used when adding or changing an applicant, is updated to be fully displayed in various mobile devices.
766	Document actions disabled for draft application documents	The document actions button is restored for draft application documents.
