ID	Title	Description
771	Inaccurate data in daily directions summary email	Inaccurate participant data and direction listings displayed in external daily directions summary emails is resolved. The issue affected emails issued when an outstanding or non-compliant response reminder, due date, or non-compliance due date passed.
782	External Login ID with special characters	Special characters are now allowed for use in Login IDs.
785	Notice of application global notification expanded	The notice of application global notification is expanded to include notices of hearing.
793	My Notifications and Recent notification items timing out	Upon arrival and login, the system's retrieval process for My notifications and Recent notifications is updated to address time out issues for users with a high volume of notification items (or proceedings).
795	iPhone display issues	Multiple interface-related and scrolling problems for iPhone users are fixed.
799	Confidential motion documents redirection error	When users navigated to the Documents screen, accessed the Confidential Motion tab, and attempted to open a confidential motion document, they were unexpectedly reauthenticated and redirected to the Search screen. The issue is corrected, and users can now seamlessly access confidential motion documents without unnecessary reauthentication or redirection.
809	Select direction to associate status error	The issue where the Select Directions window incorrectly listed compliant directions when associating a direction to a document using document actions is fixed.
810	Confidential motion tab missing warning message for group representatives	When a group representative is also representing registered interveners in the same proceeding and a motion for confidentiality is registered for one or more of the respective interveners, the required permissions warning message is restored when the representative visits the Documents screen, Confidential motion tab. Additionally, where a representative is associated to multiple motions for confidentiality, each motion is now available to be selected from a drop-down menu.
812	Documents screen exhibit sort order error	The Documents screen is updated to apply an ascending default sort order by exhibit number.
813	Draft confidential PDF documents not opening	Users no longer receive an error message when attempting to open a PDF document in a confidential draft filing.
814	Sort function not available in document uploader screen	Upon upload, documents now sort alphanumerically. Additionally, users can now sort documents in the uploader screen in their preferred order using a drag and drop feature. This ensures exhibit numbers are applied sequentially based on the custom sort.

817	Exhibit number column size	The Documents screen, Exhibit number column is adjusted to accommodate displaying longer exhibit numbers.
822	Font size consistency issues	In the Documents screen, the font size in the Exhibit number, Reference and Directions columns is adjusted for consistency. The same adjustment is made to the File Name, Applications and Directions columns in the Application details screen.
823	Confidential public summary document actions listing	The document actions list for a generated public summary document in a draft confidential filing is fixed to prevent displaying the action: Download document.
827	Inactivating current eFiling session	The system is updated to immediately disconnect logged in eFiling users from the eFiling System when the AUC deactivates the account.
831	System-generated forms issue	SIP and application forms now correctly void and regenerate with updated representative information when registrations occur on behalf of existing interveners, market participant objectors, and applicants.
832	Representative permissions to change contact information	Representatives now have system permissions to change the primary and secondary contacts of the party they represent from the following screens: Applicants, Registered parties, and Registered party details.
833	SIP form failing to regenerate	The system-generated SIP form is fixed to regenerate when representative contact information is updated and when a group's primary representative changes. When a new primary representative is added to an existing group, the contact fields in the Registered party details screen are fixed to now populate the information in the top grid. Additionally, contact fields in the top of the Registered party details screen are realigned for consistent formatting.
834	Exhibit number assignment failing	We have resolved an issue where automatic exhibit number assignment was failing when users changed a document's description in a draft filing using document actions.
835	Unresponsive contact actions for single-user accounts	In the Registered Parties and Applicants screens, users with single-user accounts previously encountered unresponsive buttons within the contact details window when attempting to change or remove a contact. These actions are not applicable to single-user accounts and have been removed.
836	Confidentiality filing: error during document description update	An unhandled error and screen freeze occurring when modifying a document description in the draft filing screen for a confidential filing paired with a system-generated summary page for the public record is fixed.
841	IOS devices not supporting document upload	Supporting the Upload feature in Chrome and Safari browsers on IOS devices is now working.
849	Confidential disposition not opening	We have resolved an issue that caused authorized users to receive an error message when attempting to open a confidential disposition from the Disposition Details or Documents screens.
